COMPLETION OF PLACEMENT AND CLEANSING NOTICE

New World Resources Limited (ASX:NWC) (“the Company”) advises that further to its announcement of 2 December 2020, it has now completed the placement of 200,010,000 ordinary shares (“Shares”) at an issue price of \$0.05 per Share (“the Placement”). The Placement was undertaken pursuant to the Company’s available capacity under Listing Rules 7.1 (87,414,657 Shares) and 7.1A (112,595,343 Shares).

 - (A) the assets and liabilities, financial position and performance, profits and losses and prospects of the Company; or
 - (B) the rights and liabilities attaching to fully paid ordinary shares.
